## **Grant Guarantee Program (GGP) Offer Letter**

This **Grant Guarantee (GGP) Offer** ("Offer") is effective <u>2/26</u>, 2021 and the Offer becomes only binding once signed by both Parties: MUNICIPIUL TÂRGU MUREŞ, public institution from Romania, headquartered in Târgu Mureş 540026, Piaţa Victoriei nr. 3, ("Local Partner");

and EON Reality Inc., a California corporation with a corporate headquarters at 39 Parker, Irvine, California 92618 United States of America ("EON"),

#### 1. The Object of the Agreement

- 1.1 Parties is concluding this Agreement based on the importance of high-quality digital education, part of which XR (Virtual Reality and Augmented Reality) has been identified as a key for building digital competitiveness in education.
- 1.2 The partnership is realized following the application of the Local Partner on EON's Grant Guarantee Program (GGP) Offer. EON Reality and the Local Partner agree to promote an educational collaboration based on education, research, and development and to set up an TârguMureş-EON-XR Center, also named the Center, with an EON-XR platform for 5000 students and 750 workers/internships per year, for a 5-year period. The Center components are described in the TârguMureş-EON-XR Center equipment list attached in Appendix A.
- 1.3 Based upon EON Reality experience in finding funding, parties engage with potential financiers to secure a grant. If the grant is not secured within a period of 270 days, EON Reality shall cover 95.7% of the costs of the Center equipment list attached in Appendix A under the column EON Co Investment and Grant Guarantee.
- 1.4 Upon the Center delivery, installation and commissioning, the Local Partner shall contribute with a grant guarantee fee of 1% of the TârguMureș-EON-XR Center value within 30 days after the delivery, installation and commissioning.
- 1.5 Parties also agree that 4.3% of the Center costs, representing optional additional equipment and services as specified in Appendix A under the column Funding Option, shall be subject of an additional financing option to the Local Partner, based upon his own decision, with no interest and no fees, to be paid in 3 equal yearly installments over 3 years.

# 2. The contributions of the Parties in the execution of Academic Partnership EON-XR Center Hosting

#### 2.1. Contributions of EON Reality:

- a) to cover the actions and costs specified in its burden by this agreement, including all the costs related to cloud hosting of the Higher Education Center with a dedicated institution for the Local Partner that shall be optimized for the location selected by the Local Partner:
- b) to deliver, install and commission the Center within 90 days from the signing of this agreement;
- c) to cover for no additional charge 100% of the costs required for the EON pedagogical and technical XR team to implement the academic XR Self-Directed Learning Program including:
  - (i) A comprehensive Needs Assessment Analysis of the Local Partner's programs with concrete XR guidelines based on the Education 3.0 approach.
  - (ii) Full access to the EON-XR Resource Center with design assignments, user guides, video tutorials.
  - (iii) The execution of EON Reality's 9-step implementation plan.
  - (iv) Introduction to EON Reality's Global Academic Community for Remote Learning.

- (v) EON-XR Training Certification Level 1 and 2 online courses for all selected academic members.
- (vi) Workshops and online classes for teachers, students, and workers/interns to learn how to use and create lessons in EON-XR.
- (vii) The development of a framework for curriculum guidelines (both qualitative and quantitative).

(viii) The delivery of the EON-XR module guidelines.

- (ix) Supply material document for technical training about EON-XR Center Equipment (x) Provide Local Partner with training on new EON-XR Platform, EON Library, EON Products and Services or any other new products and services introduced into the market after the Effective Date.
- (xi) Provide supporting materials for recruitment of the VR Innovation Academy teachers and students; d) to commit to the execution of the Center and actively participate in actions which will facilitate securing external grant approval.

#### 2.2. Contributions of Local Partner:

a) actively participate in securing the grant by identifying grant sources, application process and other activities required to secure the funding:

b) prepare a press release, no later than 14 days from delivery, installation and commissioning of the Center, that will be to be jointly approved the Parties announcing the TârguMures-EON-XR Center establishment:

c) Contribute with the grant guarantee fee of \$230.000 of the TârguMureș-EON-XR Center value within 15 days after the delivery of the EON-XR Center platform for 5000 students and 750 work/internships pursuant to Appendix A and issuing the 5-year license award statement title. The balance of \$24.122 15 days to be contributed after the delivery, installation and commissioning of the EON-XR center.

d) to identify and make available a suitable space for Center establishment;

e) to manage and control the activity of the TârguMureș-EON-XR Center.

#### 3. Other provisions

- 3.1. Although other EON projects are delivered in Romania, the parties agree and guarantee that the TârguMureș-EON-XR Center will be the reference (in complexity) and the only one of its kind in Romania (e.g., in direct partnership with universities) based the Local Partner submitted Online Application terms, which have been attached here in Appendix C.
- 3.2. The delivery of the Center equipment does not involve value added tax as all Center equipment will be delivered from EON's EU Italian office. In the event there is any value added tax EON shall cover it.
- 3.3. The parties establish that, in the event of opening the Center to commercial activity, the conditions for carrying out this commercial activity will be established by a contract starting from the percentages of 30% for EON Reality and 70% for the Local Partner.
- 3.4 The Parties agree that after the five years term the Center collaboration shall continue and that all content developed as well as applications shall be hosted perpetually by EON on the Amazon web cloud service at no cost and be enabled to distribution and upload with no restrictions. Furthermore, the Parties shall work in good faith to find additional funding resources to update licenses in order to continue creation of applications for the Center. In addition, all Center equipment shipped to the Local Partner will remain in their possession and used without restriction beyond the five years' term.

#### **Execution and Date**

THIS OFFER is now fully executed with an Effective Date as completed by the last signing Party.

This agreement is conditioned by the receipt of an official budget in March by the Local Partner and prepared for the purpose of securing the \$25 million for the Local Partner, given that the expiration date for the Grant Certificate is in February. In the event the budget is not received, this agreement is terminated with no obligation for either party.

Meanwhile, the parties committed to keep this agreement confidential and not disclose it to any third

parties until it becomes binding. In this event, any comments or any type of statements made regarding the agreement are based on a mutual understanding and approval.
